- Therefore, it is essential to build stronger Agricultural Knowledge and Innovation Systems (AKIS) to boost initiation and development of innovation projects, to disseminate their results and to use them as widely as possible.
- Successful AKIS strategies include four main groups of actions:

AKIS - Key messages



- Knowledge and innovation have a key role to play in helping the farmers and rural communities meet challenges
 of today and tomorrow.
- 2. Policy makers, farmers, researchers, advisors, associations and media need to <u>step up their efforts</u> to develop new knowledge and innovative solutions.
- 3. Moreover, a conducive environment across the EU for quicker innovation and better valorisation of existing knowledge to achieve the <u>CAP objectives</u> and deliver on <u>international commitments</u> needs to be set up.
- 4. Therefore, it is essential to build stronger Agricultural Knowledge and Innovation Systems (AKIS) to enhance knowledge flows and boost emergence and development of innovation projects, to disseminate their results and to use them as widely as possible.
- 5. Successful AKIS strategies include four main groups of actions:
 - Enhancing knowledge flows and strengthening links between research and practice;
 - Strengthening all farm advisory services, making them strongly interconnected with the AKIS;
 - Boosting cross-thematic and cross-border interactive innovation; and in this respect the European Innovation Partnership for agricultural productivity and sustainability (EIP-AGRI) is a unique policy framework to support interactive innovation projects at local and transnational level.
 - > Supporting the digital transition in agriculture.



Where does AKIS stand in the new CAP?



- In the 2023-2027 CAP, the AKIS strategic approach has been enshrined for the first time in the policy architecture and contributes to the Cross-Cutting Objective of modernisation, knowledge sharing, innovation, and digitalisation.
- In CAP Strategic Plans (2023-2027), Member States have shown their AKIS strategic approach, which will contribute to the achievement of the Cross-Cutting Objective by providing a description of the organisational set-up of AKIS and a description of how advisory services, research and the national CAP Networks will cooperate to provide advice, knowledge flows and innovation services.
- The overarching aim of the CAP modernisation, where AKIS plays a significant role, is the long-term supply of nutritious food and biomass and the achievement of the 2030 Sustainable Development Goals. To this end, knowledge and innovation (including tackling the research and digital divides) through a well-functioning AKIS in Member States will play a key role.

3. KNOWLEDGE SHARING, INNOVATION AND DIGITALISATION

Ireland has a well-structured and interactive approach to fostering knowledge, innovation and digitalisation in agriculture and rural areas. This involves clear coordination and collaboration within the Agricultural Knowledge and Innovation System (AKIS).

Ireland will keep building and improving its AKIS and provide training and advisory activities for farmers to help them address new challenges, including those related to the environment and digitalisation.

A similar purpose will also be pursued by 36 European Innovation Partnership Operational Groups, which will address the innovation gap between research and the practices implemented in the field.

- Around 300 000 persons will benefit from advice, training or knowledge exchange or participate in European Innovation Partnership Operational Groups supported under the Irish CAP Plan, mainly in the field of environmental or climate-related performance.
- Over 10 000 advisors will be supported in their work to make innovation available to farmers.



- Provide farmers with a platform to share knowledge and to engage in peer-to-peer learning
- Targeted at key challenges and issues identified whilst maintaining a degree of flexibility to tailor content to own experience, circumstances and requirements.

Approach:

- High quality and targeted advice to farmers through KT Groups, delivered by professional (public & private) agricultural advisors (KT Facilitators) with appropriate FAS training, CPD, experience and expertise.
- Each year, each Knowledge Transfer Group deliver four meetings from a list of 'Priority KT Topics' & four meetings on topics decided by the Group itself. Priority KT Topics' must incorporate delivery from an appropriate external expert.
- Each KT Facilitator will hold a one to one meeting with each farmer in his/her group in order to set goals for the programme and report on progress in relation to same.
- The total indicative financial allocation for this intervention is €71.1m for the period 2023-2027.
- Built-in AKIS development opportunities:
 - Latest R&I developments
 - Development of interactive innovation skills and approaches
 - Develop place-based innovation and data driven decision making

Knowledge Transfer





- Provide support and resources for the up-skilling and the continuous professional development of <u>public & private</u> advisors
- Enhance knowledge base and ensure familiarity with the latest practice, techniques, technologies, and regulatory and scheme requirements in a rapidly changing agricultural industry

Approach:

- Blended approach to learning incorporating online and inperson learning in a manner consistent with existing FAS training delivery
- Online platform & module tendering process.
- Financial allocation of €1.9m for the period 2023-2027.
- Built-in AKIS development requirements:
 - Latest R&I developments
 - Outputs for KT measure
 - Development of interactive innovation skillset
 - Development of agri-digitalisation skills

CPD for Advisors






 Provide support to a range of actors in the agricultural sector to form Operational Groups (OGs) to develop place based and test innovative solutions

Approach:

- Competitive calls for proposals for innovative projects related to specific challenges
- Stream A competitiveness, modernisation, structural and animal health and welfare challenges
- Stream B environmental, biodiversity, climate change challenges.
- The total indicative financial allocation for this intervention is of €36.12m for the period 2023-2027.
- Built-in AKIS development requirements:
 - Specific themes: generational renewal, gender balance, environmental challenges, uptake of agri-digital tools, and integration & development of bioeconomy at farm level
 - Link to CPD & KT developments



Approach:

- Support under this intervention is provided to Local Action Groups (LAGs) to implement pre-defined Local Development Strategies (LDSs) in their local areas.
- Each LDS examine the potential within the LDS process and in the context of an integrated regional and local planning approach on themes including Sustainable Development of Rural Environment and Climate Change Mitigation.
- The total indicative financial allocation for this intervention is €180 Million for the period 2023-2027...



Approach:

- Development of an innovation support service (Art 15(4)(e) focusing on fostering innovation and supporting the inclusion of, and the interaction between, all stakeholders in the knowledge-exchange and knowledge-building process
- New National CAP Network in situ to coincide with the commencement of the new programming period in 2023
- AKIS related considerations:
 - Highlighting the availability of CAP and Horizon Europe funding
 - Provide a platform for actors to meet, and create, develop and test grassroots and innovative ideas.
 - Provide support and advice to multi-actors groups in the field who may be looking to form an operational group
 - Link with Teagasc Signpost Farm Programme & the National Agricultural Sustainability Research and Innovation Centre
 - Facilitate the translation of research outcomes from a wide range of literature into guides for practical implementation by primary producers or operational groups

- Embed validated knowledge transfer methodologies into research and innovation funding programmes
- AKIS related considerations:
 - Improve knowledge transfer implementation in research and innovation projects
 - Involvement of end-users such as farmers/farmers' groups, advisors, businesses, etc in research and innovation projects

Research





 AKIS coordination, structuring and mobilising bringing actors together on a planned and regular basis, creating consistent engagement to support modernisation, innovation and knowledge flows and speed up knowledge exchange and implementation in practice.

Approach:

- Strategic work programme with agreed activities, objectives, deliverables and appropriate monitoring and indicators.
- Establish in Q4 2023
- AKIS related considerations:
 - Strengthen the links between the actors in the AKIS
 - DAFM establish and chair an AKIS coordination group which will provide a platform to improve synergies and complementarities between people, organisations and institutions




The Irish Dairy Sector under Milk Quotas

Number of Dairy Farms









AKIS - SWOT analysis in Ireland's CSP (DAFM 2022)

Strengths:

- ObjAKIS.S1: The constituent parts of the Irish AKIS (Research, Knowledge Transfer, Farm Advisory Service, and Cooperation & CAP Network) are well established
- ObjAKIS.S6: Well-established public and private farm advisory services within the AKIS system which act as one of the main information sources for farmers.

Weaknesses:

- ObjAKIS.W1: The organisational set-up of AKIS is not structured and lacks coordination and strategic direction.
- ObjAKIS.W2: Weak relationships between certain parts of the AKIS system.
- ObjAKIS.W3: The level of agricultural research being applied in practice is insufficient.

Opportunities:

- ObjAKIS.O1: Structure the AKIS so that it is more collaborative and responsive to the needs of primary producers.
- ObjAKIS.O5: Enable equal access to training for public & private advisors.

Threats:

• ObjAKIS.T1: A non-structured AKIS will lead to inefficiencies in the agri-food sector

AKIS - Recommendations in Ireland's CSP (DAFM 2022 - final August 2022)



- 1. Significant acknowledgment that **advisors will play a central role** in addressing key challenges facing the agri-food sector and in assisting in the implementation of the range of schemes to be rolled out as part of the CAP Strategic Plan.
- 2. The **AKIS Coordination Group** will agree an implementation plan & monitoring process which will include 5 activities, which includes the '*improved networking, collaboration and development of innovation support services to strengthen links and activities between research, advisors, the farming community, the rural economy and cooperation & interactive-innovation projects'.*
- 3. Following establishment of the AKIS Coordination Group, the MA will conduct an independent review of the AKIS framework in Ireland.
- 4. Additionally, 'the organisational set-up of AKIS in Ireland currently involves numerous different policy areas, activities, organisations and instruments. This structure has organically emerged and has heavily relied on Teagasc for structure and a range of organisations for mobilisation. Due to the proliferation of activities and organisations it is now viewed from a policy perspective that further AKIS development would benefit from a coordinated framework approach'.
- 5. The aim in this CAP period would be in particular, 'to enhance the collaboration role between Teagasc, Bord Bia and the private advisory service including in particular with the Agricultural Consultants Association and with the environmental & farming community as well as the agri-food & bio-based sector and the forestry sector.'
- 6. An important element of a well functioning AKIS 'will be close collaboration between public and private advisors and access to the latest research, innovation, piloting and demonstration actions. The independent review of the AKIS framework in Ireland will consider these issues. If necessary, arising from this review the AKIS Coordination Group will seek to implement changes to improve collaboration and/or access to research, innovation, piloting or demonstration activities'.



Case Study: Thinking outside the box

Rory O'Reilly: Organic Beef Farmer
Rory O'Reilly lives in south Co. Galway
with his wife and 4 children. He is an
organic suckler beef farmer who has
found innovative ways to make a living
from heavy marginal land while also
protecting its ecology. He has developed
a new market for beef from his herd of 42
cattle by selling directly to his customers
via a box scheme at Loughmountain
Farm (loughmountain.ie).



Objectives



- Raise awareness and understanding of R&I
- Collect and appraise knowledge

Activities



- Mapping the Ecosystem: Understanding the funding programmes, stakeholders, projects, research and multipliers.

Horticulture

Key challenges:

Status




- Part of the National Consultative structure.
